3/23 Previous Minutes:

5/23 Weaverthorpe Station

Graham North from North Yorkshire Council attended the meeting to discuss the possible reopening of Weaverthorpe Train Platform.

A similar project in Haxby is forecast to cost between £15 and £20 million, but costs at Weaverthorpe would be expected to be higher due to the Grade II listed buildings on site which would need renovated as part of any project.

Applications for funding from the Restoring Your Railways Fund can be made, but any amount would need to be matched by the Local Authority, who have already agreed to fund improvements at Haxby, Seamer, Malton and Scarborough.

It is also suggested that applications for funding are considered more seriously if they are with regards a station that would serve around 3000-4000 households.

Graham also raised the point that opening Weaverthorpe as a platform again would add at least 3 minutes to each journey, which could have a knock-on effect to the number of services that take place between Scarborough and York

Due to large costs and the fact that Scarborough, Seamer and Malton are all being renovated already, it does not seem likely that funds would be available for Weaverthorpe at this time.

7/23 Clerks Reports

The Clerk emailed National Highways to confirm that the drain jetting had been carried out along the A64 and copied in the local MP. At the time of meeting, no reply had been received.

The Clerk confirmed that patching works had been carried out along St Hildas Street, but the Councillors were not happy with the poor quality of works and noted that surfaces appeared to be worse now than before.

It was proposed that a public meeting be arranged between village residents and members of North Yorkshire Council Highways team, so they could understand the level of discontent within the village and could explain why the works have failed to be carried out so far. The Clerk is to contact NYC for some possible meeting dates.
